If you are in receipt of this document, it is because you are participating in the above-named event as a vendor, but you are unable to meet the School District's insurance requirements. Because of this you will need to comply with the below:

Licensee agrees to:

1. Assume all liability for and agrees to indemnify and hold Licensor, the Old Bridge Public Schools, its respective members, officers, agents, contractors, servants, employees, representatives, volunteers, licensees or invitees, harmless from and against any and all claims, losses, damages, injuries and expenses, including reasonable attorney's fees, arising out of, resulting from, or incurred in connection with any acts or omissions of the Licensee, its members, agents, contractors, servants, employees, volunteers, licensees, or invitees related to its use of the Licensor's facilities, including but not limited to, the Licensee's use of any portable equipment. Additionally, in the event that an action or proceeding is brought against Licensor, the Old Bridge Public Schools, by reason of any such claim, the Licensee, upon notice from the Licensor, covenants to provide and fully fund a defense for Licensor, the Old Bridge Public Schools, against any such claims, at Licensee's expense, via legal counsel reasonably satisfactory to the Licensor.
2. Assume responsibility for preserving order in said designated area / facility during its use of the facilities, for all fees in connection with the Licensee's use of the facilities, including when necessary, custodial fees. Inspect premises prior to use, avoid use if dangerous condition exists and report and report any dangerous conditions to Licensor.
3. Observe and adhere to all of the Licensor's rules and regulations governing the use of the Licensor's facilities as set forth in the Licensor's policies and regulations. The foregoing policies and regulations are as much a part of this application and agreement as if they were attached hereto. Any violation of these terms and conditions may result in the immediate expulsion of the Licensee from the Licensor's facilities.
4. If the above noted event is cancelled due to inclement weather or any other reason the district deems necessary, Licensor shall not be responsible for any financial losses of the Licensee.
5. Pursuant to N.J.S.A. 18A:40-41a and N.J.S.A. 2A:62A-27, the Licensor, its employees, members, representatives, agents and servants shall not be liable for the injury or death of a person arising from the presence of and access to an AED, as well as the action or inaction of the Licensee or any of the Licensee's members, agents, contractors, servants, employees, volunteers, licensees or invitees.
6. Pursuant to N.J.S.A. 18A:40-41.5, in the event of a sudden cardiac event or concussion, the Licensor shall not be liable for the injury or death of a person due to the action or inaction of the Licensee or any of the Licensee's members, agents, contractors, servants, employees, volunteers, licensees, or invitees.
7. The Licensee shall not violate any School District, Township or state law, regulation, ordinance or policy in or about the said premise.

With the authority to bind the Licensee named herein, I have read and hereby represent that the Licensee has read and agreed to the above, and shall comply with any and all of the Licensor's rules, regulations, and policies.
